## Warm Air Hair Dryer

### Description

World warm air hair dryer, powered by a DC motor, delivering 1,000 Watts of drying power with variable temperature control. This ADA compliant hair dryer runs on 120 Volts AC electrical supply. Automatic operation initiates by removing the blower handle from the rest cradle and stops when returned. A 15 minute safety timer shuts the unit off automatically if the handle is not placed in the cradle. This appliance is intended for use in hair styling and drying. This hair dryer may be used in commercial and residential environments.

### Unpacking

1. Remove all packing material. Recycling is recommended.
2. Carefully remove the hair dryer from the shipping carton, using care not to drop the appliance.
3. Inspect carefully for any damage that may have occurred during transit. Check for any loose, missing or damaged parts.

### General Safety Information

**⚠ DANGER** Failure to unplug the unit before servicing, can result in serious injury or death from electric shock.

- Always disconnect the power source before servicing or cleaning the hair dryer.

**⚠ DANGER** Bypassing or damage to the appliance leakage current interrupter (ALCI) could result in severe electrical shock and or death.

**⚠ WARNING** Risk of fire, personal injury or property damage are possible if local codes, NEC codes or safety recommendations are not followed.

- Do not connect to an extension cord.
- Do not connect more than one (1) unit per 15A circuit.
- Do not exceed the combined rated load of the circuit.

**⚠ CAUTION** Improper mounting of this hair dryer could result in personal injury or property damage.

- Follow the mounting recommendations in Figure 1.

### Installation

1. Unplug unit.
2. Select mounting location:
  - A minimum of 24" above any surface.
  - Within easy reach of a 15A outlet. Do not stretch the cord and do not create a trip hazard.
  - When two or more dryers are installed, they should be placed no closer than 24" (60cm) from center to center.
3. Place the mounting template on the wall at the desired location. Use figure 1, as a guide. Mark the (2) mounting screw holes.
4. Using the supplied mounting screws and molys or a suitable alternative as required, securely attach the mounting hook and retainer to the wall.
5. Align the dryer to catch the hook and push against the lower retainer until flush with the wall.
6. Safely route the cord and plug to the outlet and insert.
7. Your dryer is now ready for use. If any problems are encountered, refer to the trouble shooting chart.

# World™ Warm Air Hair Dryer

## Operation

1. Remove handle from main unit. Hair dryer will start automatically.
2. Adjust the temperature control on the front of the dryer. Maximum heat and air flow for quick drying power. Low temperature offers gentler heat and air flow for optimum hair styling performance.
3. When finished using hair dryer, replace handle securely into the cradle in front of main unit. Hair dryer will turn off automatically.

**CAUTION** *As with all electrical appliances certain precautions need to be followed to ensure safe, trouble-free use of the Hair Dryer:*

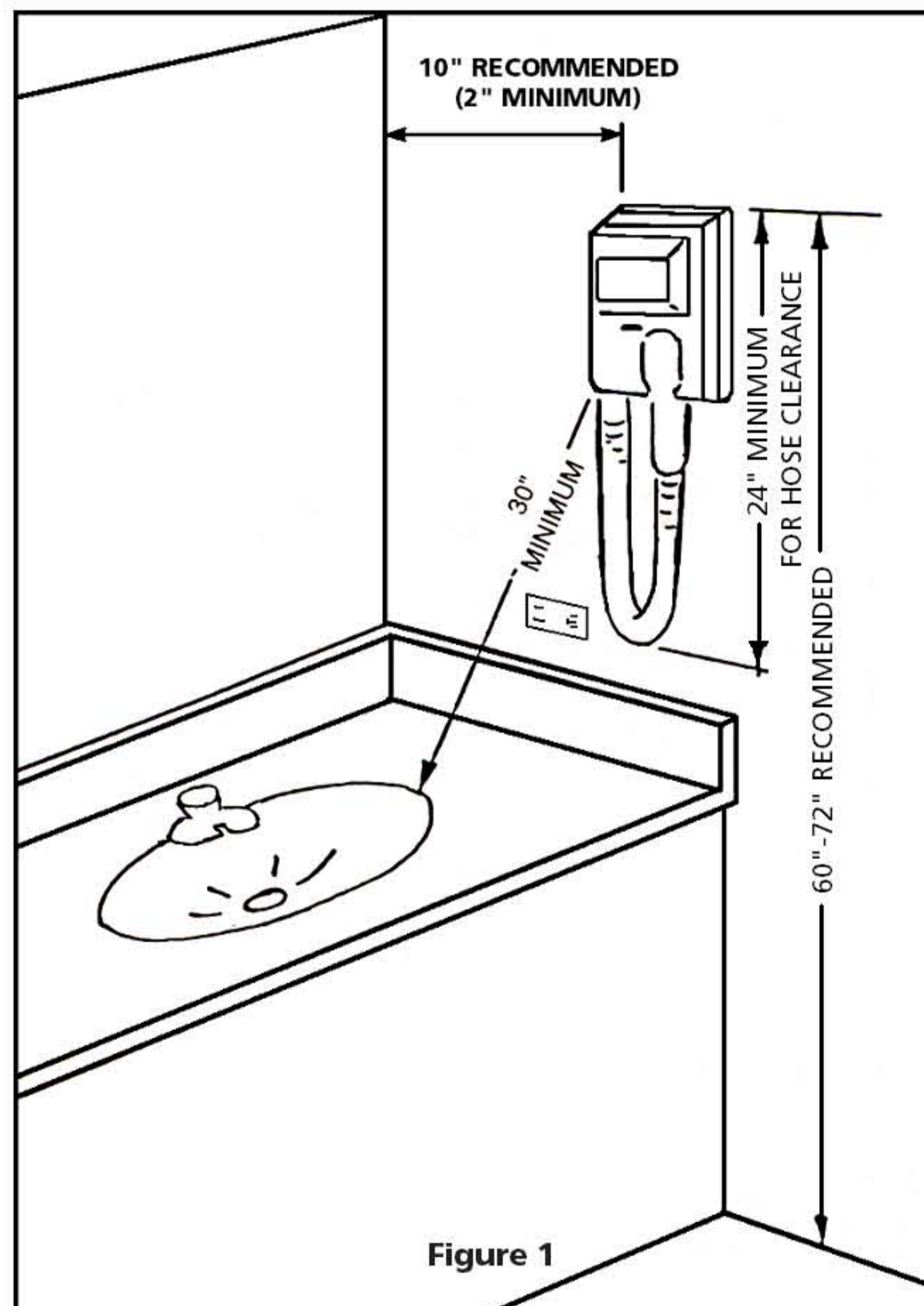
### DO NOT:

- Use hair dryer while bathing
- Let hair dryer operate unattended
- Immerse handle in water or other liquid
- Retrieve handle from water unless main power source is turned off
- Clean internal surfaces or components with water or other liquid
- Block air inlets or outlets when operating hair dryer
- Operate when using aerosol (spray) products
- Operate where oxygen is being used

DO NOT PERMIT CHILDREN TO USE HAIR DRYER UNATTENDED!

## Maintenance

1. Always keep hair dryer clean and free from dirt, lint or foreign matter. Ensure that all air inlets slots are not blocked with any debris.
2. Routinely clean external surface of the hair dryer with mild soap and water. (DO NOT USE DETERGENTS AS THIS MAY DAMAGE PLASTIC)

## Troubleshooting Chart - Corrective actions must be performed by a qualified electrician.

Symptom	Possible Cause(s)	Corrective Action
Dryer will not run	No power to unit.	<ol style="list-style-type: none"> <li>1. Confirm that the breaker supplying the dryer is operational</li> <li>2. If the hair dryer appears to "blow" its circuit breaker supplying power, check the total load on that circuit. The hair dryer requires 8.3 amps at maximum heat.</li> </ol>
Fan motor runs but no heat	Open thermal protector	<ol style="list-style-type: none"> <li>1. The hair dryer has internal reset protection against overheating. However if the hair dryer air intake is blocked for an extended period, the internal thermal protection may cut power to the heating element permanently. This is a safety feature. Make certain that the air flow entering and exiting the hair dryer is not blocked.</li> </ol>
